Whereas, the Government has considered the matter and decided that further extension in time for making the award by the Arbitrator be granted.

Now, therefore, in exercise of the powers conferred by sub-rule (1) of rule 10 of the Jammu and Kashmir Requisitioning and Acquisition of Immovable Property Rules, 1969, the Government hereby direct that the time for making the award shall and shall always be deemed to have been extended by a further period of one year w.e.f 21st of August, 2017.
