SRO 323 In exercise of the powers conferred by proviso to the section 124 read with sub-section (2) of section 133 of the constitution of Jammu and Kashmir, the Governor hereby makes the following amendment in the Jammu and Kashmir, Health and Family Welfare (Gazetted) Services Recruitment Rules, 2013 notified vide notification SRO 325 of 2013; namely:-

“in Schedule-II, Columns V and VI relating to the qualification and method of recruitment for the post of ‘Dental Specialist’ in ‘Class III’ ‘Category F’ shall be substituted by the following columns; namely:-

<i>Minimum qualification</i>	<i>Method of Recruitment</i>
<i>Possession of Postgraduate degree in Dentistry recognized by Dental Council of India with two years experience in a responsible position connected with the specialty.</i> <i>Or</i> <i>Possession of Post Graduate diploma in Dentistry recognized by Dental Council of India with five years experience in the profession in a responsible position connected with the specialty.</i>	<i>i. 60% by direct recruitment</i> <i>ii. 40% by promotion from the senior most Dental Surgeon possessing Post-Graduate degree/diploma in the Dentistry recognized by Dental Council of India with at least two years experience after post Graduation.</i>


