580 366 - In exercise of the powers conferred by section 148 of the Jammu and Kashmir goods and Services Tax Act, 2017 (Act No. V of 2017), the State Government, on the nonmendations of the Council, hereby notifies the registered persons having aggregate turnover tup to 1.5 crore rupees in the preceding financial year or the current financial year, as the class of egistered persons who shall follow the special procedure as mentioned below for furnishing the tals of outward supply of goods or services or both.

The said persons may furnish the details of outward supply of goods or services or both in FORM GSTR-1 of the Jammu and Kashmir Goods and Services Tax Rules, 2017, effected during the quarter as specified in column (2) of the Table below till the time period as specified in the presponding entry in column (3) of the said Table, namely:-
