SRO **536** .— In exercise of the powers conferred under clause (b) of sub-section (2) of section 3 of the Jammu and Kashmir Legal Services Authorities Act, 1997 and in supersession of Notification SRO 369 of 2018 dated 04<sup>th</sup> September, 2018, the Government, in consultation with the Hon'ble Chief Justice of the High Court of Jammu and Kashmir, hereby nominate Hon'ble Mr. Justice Rajesh Bindal, Judge of the High Court as Executive Chairman of the State Legal Services Authority constituted vide Notification SRO 68 of 1998 dated 18<sup>th</sup> February, 1998.

The nomination shall be for a period of three years from the date of issuance of this Notification.
