Jammu, the 5th February, 2018

RO 68.- In exercise of the powers conferred by section 5 of the Jammu Kashmir Levy of Toll Act, Samvat 1995 (Act No. VIII of 1995), the overnment hereby directs that import of following items in the State shall e exempt from payment of Toll leviable under the said act.

- Sanitary items (Toilets seats-Indian, Western & Urinals, Washbasin, Pedestal, Bidet, Bathtub, Sink and accessories like soap holder, towel rod and toilet paper holder, Taps, showers, Faucets but shall not include pipes to be used for bathroom fittings)
- Jaggery (Gur)
- 3. Sugar
- 4. Medicines for human and animal consumption.
- 5. Vegetables (leafy, Non-leafy including Onion, Potato, Garlic and Ginger etc.)
- Newsprint paper
- 7. Tea
- 8. Tree Spray Oil
- 9. Wheat seed
- 10. Salt (lodized)
- 11. Soaps (Soaps used by humans for bathing, washing of clothes and utensils and Detergents (liquid, cakes and powder.)
- 12. Narial (Coconut with water)
- 13. Pulses

This notification shall come in force w.e.f 6th February 2018.
