Jammu, the 22nd of January, 2019

SRO 14 .-In exercise of the powers conferred by sub-section (1) of section 11 of the Jammu and Kashmir Goods and Services Tax Act, 2017 (Act No. V of 2017), the State Government, on the recommendations of the Council, hereby makes the following amendments in the notification SRO-GST-2; dated: 08-07-2017, namely:-

In the said notification, -

(j) for S. No. 43A and the entries relating thereto, the following serial numbers and the entries shall be substituted, namely:-

"43A	0710	Vegetables (uncooked or cooked by steaming or boiling in
		water), frozen
43B	0711	Vegetables provisionally preserved (for example, by sulphur dioxide gas, in brine, in sulphur water or in other preservative solutions), but unsuitable in that state for immediate consumption";

(iii) after S. No. 121 and the entries relating thereto, the following serial number and the entries shall be inserted, namely: -

"121A 4904 Music, printed or in manuscript, whether or not bound or 00 00 illustrated";

(iii) after S. No. 152 and the entries relating thereto, the following serial number and the entries shall be inserted, namely: -

"153	Any	Supply of gift items received by the President, Prime Minister,
	chapter	Governor or Chief Minister of any State/ Union Territory, or any
		public servant, by way of public auction by the government, where auction proceeds areused for public or charitable cause".

This notification shall come into force w.e.f. 1st of January, 2019.
