> Notification, Jammu, the 26<sup>th</sup> of March, 2019

SRO23 .- In exercise of the powers conferred by sub-section (3) of section 7 of the Jammu and Kashmir Non-Biodegradable Material (Management, Handling & Disposal) Act, 2007, the Government of Jammu and Kashmir, after consultation with the prescribed Authority(Jammu and Kashmir State Pollution Control Board) hereby bans completely, the following articles made of nonbiodegradable material listed in Schedule-I of the said Act, within the territorial jurisdiction of the State of Jammu and Kashmir; namely:-

a. Disposable plates.

b. Disposable cups, bowls and tumblers.

c. Disposable spoons, forks and knives.

This notification shall be deemed to have in force after one month from the date of its publication in the Government Gazette.
