NOTIFICATION

Jammu, the 3rd December, 2020

S. O. 371 Whereas, on 08.06.2020, Police Baramulla during random checking at Kralahar intercepted a scooty rider identified as Irfan Ahmad Wani S/O Ghulam Nabi Wani R/O Shutloo Rafiabad. The scooty was without registration number. During his personal search, Police recovered one Chinese Pistol alongwith one pistol magazine and 04 pistol rounds. Subsequently the accused was arrested in the case on the spot,; and

2. Whereas, a case FIR NO. 81/2020 U/S 7/25 A. Act, 23,38 ULA (P) Act, 1967 was registered in Police Station Baramulla and investigation of the case was taken up; and

3. Whereas, during the course of investigation, site plan of place of occurrence and seizure memo was prepared and statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and

4. Whereas, during the course of investigation it was revealed that the accused Irfan Ahmad Wani associated himself with the banned

terrorist organization (HM) and was providing transport facility to the terrorists of the HM outfit; and

5. Whereas, on the basis of investigation, statement of witnesses recorded and other evidence collected, the investigating officer has prima facie established involvement of the below mentioned accused for commission of offence punishable under section 23,38 of Unlawful Activities (Prevention) Act, 1967:-

6. Whereas, the Authority appointed by the Government under sub-section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967 has independently examined the case diary file and all the other relevant documents relating to the case and has come to the conclusion that prima facie case is made out against the above accused: and

7. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under sub-section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for his prosecution under the provisions of law; and

Now, therefore, in exercise of powers conferred by sub section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accords sanction for launching prosecution against the above mentioned accused for the commission of offences punishable under section 23,38 ULA (P) Act, in the case FIR No. 81/2020 of Police Station Baramulla.


