S.O. 409 .- In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Lieutenant Governor is pleased to direct that Article 41-G of the Jammu & Kashmir Civil Services Regulations, Volume-I shall be substituted by the following; namely:-

"41-G. Secretariat Allowance

- (a) Government employees who are working in Civil Secretariat Srinagar/Jammu shall be entitled to Secretariat Allowance. The employees of the offices of HoDs situated outside the Civil Secretariat who were entitled to Temporary Move Allowance shall also be entitled to Secretariat Allowance. Secretariat Allowance shall be paid at a uniform rate of Rs. 2000/per month.
- (b) The following conditions shall govern the grant of Secretariat Allowance:
 - i. The allowance shall be admissible to the whole time Government servants including those borne on contingent paid establishment working in such offices but excluding employees on contract, consolidated rates of pay or part-time employees.
 - ii. The allowance shall be admissible throughout the year.
 - iii. During leave, the allowance shall be admissible only in respect of earned leave and limited to a period of two months.
 - iv. The allowance shall not be admissible during joining time or transfer, if transfer is outside Civil Secretariat, Jammu or Civil Secretariat, Srinagar or offices as specified in (a) above. As soon as Government servant is relieved by way of above arrangement, the drawal of allowance will cease forthwith."
