Srinagar, the St. of August, 2021

**S.O.** 264 -Whereas, Shri Abdul Ahad Sheikh (Claimant) has filed an application dated 18.11.2019 before the conciliation officer against the management of M/s General Manager, Ellaquai Dehati Bank, Wazir Bagh, Srinagar, stating that he has remained under their employment from 1<sup>st</sup> may 2004 on monthly wages; and

Whereas, on 15<sup>th</sup> of April, 2019, the Management, terminated the applicant from services without giving any notice; and

Whereas, the Management has filed their objections and have challenged the present claim of applicant on the pretext that, he was not working in their office; and

Whereas, the conciliation officer has submitted his failure report recommending the case for its reference to the Labour Court for adjudication; and

Whereas, the Government is of the opinion that an industrial dispute exists between General Manager, Ellaquai Dehati Bank, Wazir Bagh, Srinagar and the applicant; and

Whereas, the Government considers its desirable to refer the said dispute to the Labour Court/Tribunal for adjudication.

Now, therefore, in exercise of the powers conferred under clause (c) of sub-section (1) of section 10 of the Industrial Dispute Act, 1947 (XIV of 1947),

the Government hereby refers the said dispute to the Labour Court/Tribunal for adjudication on the following issues:-

- Whether the applicant was employee of Ellaqui Dehati Bank, Wazir Bagh, Srinagar, if yes:
  - a) Whether his termination is illegal; and
  - b) What are the benefits, he is entitled to from the Management of Ellaquai Dehati Bank, Wazir Bagh, Srinagar.
