Jammu, the 12th of DEC., 2022.

S.O. 676 .—In exercise of the powers conferred by proviso to Article 309 of the Constitution, the Lieutenant Governor is pleased to direct that following shall be added as proviso 2nd to clause (a) of Article 260-B of Jammu & Kashmir Civil Services Regulations, 1956 (Vol.I); namely:-

“Provided further that the ignorable portion of the pension w.e.f 01.01.2016, shall be Rs. 15000/-. The existing limits of pension to be ignored in fixing the pay of re-employed pensioners will, therefore, cease to be applicable to cases of such pensioners as are re-employed on or after 01.01.2016. In case of persons who are already on re-employment as on 01.01.2016, the pay may be fixed on the basis of these orders, with effect from the date of coming over to the new pay structure, i.e. 01.01.2016 or later, as per the option exercised by them in the manner laid down in Rule 5 and Rule 6 of the Jammu & Kashmir Civil Services (Revised) Pay Rules, 2018, within three months of the date of issue of these orders. In such case, their terms would be determined afresh as if they have been re-employed for the first time from such date of coming over to the new pay structure.”
