S.O 506.- In exercise of the powers conferred by proviso to Article 309 of the Constitution of India read with Section 15 of the Jammu and Kashmir Civil Services (Decentralization and Recruitment) Act, 2010, the Lieutenant Governor is pleased to direct the following amendment shall be made in the Jammu and Kashmir Civil Services (Decentralization and Recruitment) Rules, 2010; namely:-

In Rule 6, for sub-rule (1), the following sub-rule shall be substituted:-

"(1) There shall be constituted a Service Selection Board for making selection for recruitment to Subordinate Services/non-gazetted/ Class-IV (MTS) posts borne on the establishment of any Department or Service of the Undertaking/ Sector any Public or Government Company/Corporation/Board/Organization Government and body substantially owned or controlled by the Government of Union territory of Jammu and Kashmir."
