S.O 6 .-In exercise of the powers conferred under Section 473 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023 read with S.O 2506 (E) of 2024 dated 28<sup>th</sup> of June 2024 of the Ministry of Home Affairs, Government of India, the Lieutenant Governor is pleased to order that the remaining term of imprisonment of the life convict prisoners, mentioned in the **Annexure** to this notification, shall be remitted with effect from the date of issuance of this notification, subject to the following conditions:

 That they will maintain peace, good character and behaviour in the society at all times.

That they will not indulge into any unlawful activity which is prejudicial to the maintenance of the public order or security of State.

 That they will not intimidate any member/relative of victims' family in any manner, whatsoever.

 That they will ensure their presence before concerned Police station once in six months.

That they will furnish, both surety bond and personal bond, to the satisfaction of concerned Superintendent Jails before their release.

The Police Stations concerned will keep watch on the activities of the released prisoners. In case of violation of any of the conditions, their premature release shall be liable for cancellation.
