Subject:- Final Seniority List of the Associate Law Officers, District Cadre.

Circular No: 08 - JK(LD) of 2023. Dated : 19 - 05 - 2023.

Whereas, the Department of Law, Justice & Parliamentary Affairs referred twenty(20) posts of Legal Assistants (now re-designated as Associate Law Officers) in the pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4280/- (pre-revised) available in various Districts (District Cadre), under different indents on 24 -10-2014 to the Jammu & Kashmir Services Selection Board (SSB) for making selection. A common selection process was conducted by the Service Selection Board for all the posts referred, merit was assessed and select lists drawn separately for each district cadre; and

Whereas, on the recommendations of the Service Selection Board made vide,-

- i. communication No. SSB/ Secy/Sel/2016/19164-70 dated 29-08-2016, 12 candidates were appointed as Legal Assistants (now redesignated as Associate Law Officers) (District Cadre) in the pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4280/- (prerevised) vide Government Order No. 2553-LD(Estt) of 2016 dated 23-09-2016, one each in the Districts of Anantnag, Bandipora, Baramulla, Budgam, Kupwara, Pulwama, Srinagar, Jammu, Kathua, Poonch, Reasi and Samba. The order, inter-alia provided that the inter-se-seniority of the appointees shall be as per the merit as it existed in the select list;
- ii. communication No. SSB/Secy/Sel/2016/19164-70 dated 29-08-2016, one candidate was appointed as Legal Assistants (now redesignated as Associate Law Officers) (District Cadre Pulwama) in the pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4280/-(pre-revised) vide Government Order No. 2772-LD(Estt) of 2016 dated 17-10-2016;

- iii. communication No. SSB/Secy/Sel/137/2016/19976-78 dated 11-11-2016, one candidate was appointed as Legal Assistants (now re-designated as Associate Law Officers) (District Cadre Shopian) in the pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4280/- (pre-revised) vide Government Order No. 3017-LD(Estt) of 2016 dated 23-11-2016;



iv. communication No. SSB/Secy/Sel/2016/20735-38 dated 08-12-2016, four (4) candidates were appointed as Legal Assistants (now re-designated as Associate Law Officers) (District Cadre) in the pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4280/(pre-revised), one in each in the Districts of Ramban, Udhampur, Kishtwar and Doda vide Government Order No. 3561-LD(Estt) of

2016 dated 21-12-2016. The order, inter-alia stipulated that the inter-se-seniority of the appointees shall be as per the merit as it existed in the select list;

v. communication No. SSB/Secy/Sel/2017/208-214 dated 06-01-2017, No. SSB/Secy/ Sel/2017/1130-32 dated 24-01-2017 and No. SSB/H-4y/ 2016/17/9171-72 dated 18-09-2017, one candidate each was appointed as Legal Assistants (now re-designated as Associate Law Officers) (District Cadre) in the pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4280/- (pre-revised) in the Districts of Ganderbal, Rajouri and Kulgam vide Government Order Nos. 182-LD(Estt) of 2017 dated 11-01-2017, No. 400-LD(Estt) of 2017 dated 06-02-2017 and No. 5270-LD(Estt) of 2017 dated 20-10-2017 respectively. The orders, inter-alia stipulated that the inter-se-seniority of the appointees shall be as per the merit as it existed in the select list; and

Whereas, in terms of the Jammu and Kashmir Legal (Gazetted) Service Recruitment Rules, 1980, promotion to the posts of Assistant Legal Remembrancer in the Jammu and Kashmir Legal (Gazetted) Service has to be made from Associate Law Officers . This has necessitated drawing up of a combined seniority list of the Associate Law Officers (District Cadre) to enable filling up of the available posts of Assistant Legal Remembrancer from eligible Associate Law Officers; and

Whereas, the seniority of the appointees to a service has to be determined in terms of Rule 24 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. For better appreciation, the said rule is reproduced below:-

"24. Seniority:-


(1) The seniority of a person who is subject to these rules has reference to the service, class, category or grade with reference to which the question has arisen. Such seniority shall be determined by the date of his first appointment to such service, class, category or grade as the case may be.

Note 1.-The rule in this clause will not effect the seniority on the date on which these rules come into force of a member of any service, class, category or grade as fixed in accordance with the rules and orders in force before the date on which these rules come into force.

Interpretation.-The words "date of first appointment" occurring in the above rule will mean the date of first substantive appointment, meaning thereby the date of permanent appointment or the date of first appointment on probation on a clear vacancy, confirmation in the latter case being subject to good work and conduct and/or passing of any examination or examinations and/or tests:

Provided that the inter se seniority of two or more persons appointed to the same service, class, category or grade simultaneously will, notwithstanding the fact that they may assume the duties of their appointments on different dates by reason of being, posted to different stations, be determined:

- (a) in the case of those promoted by their relative seniority in the lower service, class, category or grade;
- (b) in the case of those recruited direct except those who do not join their duties when vacancies are offered to them according to the positions attained by and assigned to them in order of merit at the time of competitive examination or on the basis of merit, ability and physical fitness etc., in case no such examination is held for the purpose of making selections; and
- (c) as between those promoted and recruited direct by the order in which appointments have to be allocated for promotion and direct recruitment as prescribed by the rules".

Whereas, the merit position and date of appointment of the 19 Associate Law Officers is tabulated as under:-

- Date of first appointment as Associate Law Officer.
- Where date of appointment is same, merit position as communicated by the Service Selection Board based on the common selection process.
- Where the merit position and date of appointment are same, iii. age of the candidate will take precedence.

Whereas, vide this department's Circular No. 06-JK(LD) of 2023 dated 09.05.2023, a tentative seniority list was issued for inviting objections, if any, from the interested persons;

Whereas, all the officials figuring in the tentative seniority list have furnished their "no objection" qua their placement at different positions in the said seniority list;

NOW, therefore, the final seniority list of the Associate Law Officers of District Cadre is notified forming "Annexure-A" to this Circular.
